- Canadian contributions now \$3 417 605, 55% of our target. Has your Club made a contribution?

- No matching grants were approved for Canada! (No applications were received!) For the year 2021-22, 8 Grants were approved in Canada for \$249 434. Internationally, 561 Grants have been approved for \$18 267 229.
- Partnerships are an important part of LCIF's action plan. Some significant
 partnerships include Anthem Foundation, Johnson and Johnson Vision, Latter-Day
 Saints Charities and Walt Disney Corporation/ESPN. As well, LCIF continues its very
 close relationship with The Carter Foundation, Special Olympics, Global HOPE, and
 the Measles/Rubella Initiative and many others.
- The Lions Legacy Program is now available in Canada! You can make a "planned gift" to the Lions of Canada Fund for LCIF.
